



## Planning – Entry and Tenure Course

Carried out predominantly by the Coordinators appointed by the Prosecutor General, with pedagogical support from the ESMPU team.

Hybrid courses with an average of 100 hours. Made up of theoretical and practical modules.



### **Execution of Academic Activities**



The activities are assigned to Instructional Design pairs, who carry out all the stages from pedagogical planning, execution of the activity to the final procedures.

Design

- Support for the Pedagogical Project by the Pedagogical Advisor;
- Hiring teachers;
- Infrastructure items;
- Student selection notice.

#### Implementation

- Monitoring the faceto-face or distance learning course;

## Assessment






#### Learning assessment

Applied to postgraduate courses and free courses for certification purposes.

#### **Reaction evaluation**

Applied at the end of the academic activity to identify the student's immediate perception.





#### Impact assessment

Applied 3 to 6 months after the end of the course for the student to report the impact of the learning on their work.

### Points of suggestions for a bilateral cooperation agreement:

- Collective study of judicial decisions in cases from both countries
- Study of what, how and why to instigate the implementation of international court dialogue, with direct application in priority situations in Brazil (e.g. in themes of socio-environmental conflicts in the Amazon, water and food security and the health of vulnerable communities and traditional peoples);
- Research of Brazilian cases with a sentence handed down by the Brazilian Judiciary
- Research of Brazilian cases with reparations under supervision (e.g.: quilombola community of Alcântara and the case of the Xucuru Indigenous People for Free, Prior and Informed Consent)


### Points of suggestions for a bilateral cooperation agreement:

- Research of almost 90 reparations ordered by the Court
- Research of pending repairs
- Study of formal paths for the control of conventionality, court dialogues and social participation justice in Brazilian courts (e.g. recommendations from the National Council of the Public Ministry and the Brazilian National Council of Justice)
- Carry out exchange and cooperation programs for graduate courses in Brazil and abroad (Germany)
- Joint publications in both countries (Germany and Brazil)



#### Possible themes for joint publications: legal aspects of the crisis that puts the largest tropical forest on the planet at imminent risk

"The possibility that the Amazon forest system could soon reach a tipping point, inducing large-scale collapse, has raised global concern. For 65 million years, Amazonian forests remained relatively resilient to climatic variability. Now, the region is increasingly exposed to unprecedented stress from warming temperatures, extreme droughts, deforestation and fires, even in central and remote parts of the system" (Nature, 2024).

### Ideas for a joint paper on the topic:

 Equation: hypervulnerability + risks – governance = needs for new and more effective safeguards

 According to decisions of the Courts (Inter-American) Court of Human Rights and the German Federal Constitutional Court), the Brazilian State must protect victims, not only through compliance with legislation and justice, but also through executive and judicial actions, within the scope of the order constitutional.



### Ideas for a joint paper on the topic:

 Appreciation of the ESG (environmental, social, governance) factor, clearly aimed at reducing environmental and social impacts.

 The integration of a gender perspective in water resources management aims to ensure that the experiences and concerns of men and women are part of the preparation, implementation, control and evaluation of water policies and programs in the Legal Amazon.
